No provision of this Agreement shall be waived, modified, altered or amended, except in writing signed by Senior Management of Bakersfield Pipe And Supply Inc.
2. All charges are due and payable 30 days from the date of Invoice. Undersigned agrees to pay a service charge of 1.5% (18% per annum) on all charges past due. Payments will be credited first against accrued interest and then Invoiced Charges. Undersigned agrees that all funds from anyone or received by Me/Us to the extent those funds result from the labor or material supplied by Bakersfield Pipe And Supply Inc. shall be held in trust for the benefit of Bakersfield Pipe And Supply Inc. There will be a \$25.00 charge on non-sufficient funds checks returned.
3. Undersigned agrees that this Agreement shall govern all 'delivery without signature' deliveries should this Applicant fail or be unable to sign any Delivery Documents.
4. California Law shall govern this Agreement notwithstanding any choice of law rule to the contrary. Undersigned agrees that this Agreement is entered into in Kern County, State of California. The Agreement shall be enforced as is any provision, which has been finally determined by a court of competent jurisdiction to be invalid under any applicable laws or regulations, was omitted. In the event that it becomes necessary for Bakersfield Pipe And Supply Inc. to employ an attorney or collection agency to enforce any of its rights, borrower agrees to pay Bakersfield Pipe And Supply Inc. the actual amount of all costs, expenses and fees incurred in connection herewith whether or not suit is filed. FOB is Bakersfield Pipe And Supply Inc. in Bakersfield, California.
5. **Terms and Conditions of All Sales:** (a) **Delay.** Seller shall not be liable for failure to deliver or delays in delivery occasioned by causes beyond seller's control, including without limitation, strikes, lockouts, fires, embargos, war or other outbreak of hostilities, acts of God, inability to obtain shipping space, machinery breakdowns, delays of carriers or suppliers, and domestic or foreign or governmental acts or regulations. (b) **Waiver.** All claims shall be deemed waived unless made in writing, delivered to Seller within 10 days after receipt of goods by buyer. (c) **Inspection.** Buyer shall afford seller prompt and reasonable opportunity to inspect goods as to which any claim is made as above stated. Seller reserves the right, in its sole discretion, to repair or replace any claimed defect in the goods. (d) **Cancellation of Merchandise.** Cancellation of standard items may be honored only if the request is received prior to shipment. Custom made or special items may not be cancelled unless cancellation precedes the in-process manufacture of the item. (e) **Manufacturer Warranties.** Buyer must comply with all original manufacturer's terms and conditions for any warranty claims that may arise. Seller does not warranty the merchandise sold beyond the terms of such warranty offered by the manufacturer, if any. Neither Bakersfield Pipe And Supply Inc. nor the Manufacturer warranties the product if it has failed due to corrosion, misuse or damage; (2) it has been altered, repaired or modified in any way that would adversely affect its operation; or (3) it was installed or operated other than in accordance with the manufacturer's operating instruction. (f) **Returns.** All returns may be subject to a restock charge.
